**New Business**

1. Reznick presented Title VI Plan Updates required by the Federal Highway Administration. Motion by Campbell, second Bowen, to approve the amendments. Motion carried.
2. Patty Horn, Dimondale Home Culture Club, stated that the Club would like to donate an AED device for use at the Village Office. Motion by Campbell, second Tardino, to accept the offer. Motion carried.
3. Reznick presented a quote for \$3,500.00 for stonework on the Danford Park bathroom. Motion by Campbell, second Bower, to approve the quote pending Village selection of the stonework. Motion carried.
4. Reznick introduced a Special Event Application from the Lions Club for the annual Halloween celebration downtown. Motion by Conarton, second Campbell, to approve the application. Motion carried.
5. Reznick introduced a preliminary request for the Car Show on June 13, 2024. Denise Parisian, Dimondale Business Association, stated that the event will be the same as the previous year. Motion by Campbell, second Haidamous, to provide preliminary approval. Motion carried.
6. Reznick presented a recommendation from the Planning Commission to approve a Special Use Permit (SUP) for 140 N. Bridge Street, for outdoor service and seating. Conarton requested a voting abstention due to possible financial gain. Motion by Campbell, second Tardino, to approve the abstention. Motion carried. Motion by Campbell, second Haidamous, to approve the SUP as presented, subject to passing fire inspections. Motion carried, Conarton abstained.

7. Reznick presented Ordinance 2024-4, Fire Prevention Code Amendments. Conarton questioned any changes affecting Village residents. Motion by Bowen, second Campbell, to approve the Ordinance as presented. Motion carried.

8. Reznick presented the MML Property and Liability Pool Ballot of two candidates for two positions. Motion by Campbell, second Tardino, to approve the slate. Motion carried.

9. Reznick introduced the mural for member consideration. Discussion followed regarding loss of grant money, possible need to return private donations, expenses already incurred, increased direction for the Arts Commission, and developing a collaborative relationship between Council and the Arts Commission. Tiedeman will follow up with the two private donors regarding the disposition of funds.
